3 **Resolution authorizing the Office of Contract Administration to enter into a contract**  
4 **agreement between the City and County of San Francisco and Cornerstone Technology**  
5 **Partners II JV, a Technology Marketplace, Tier 1B Specialist contractor, for an amount**  
6 **not to exceed \$12,000,000 for an initial three year term to commence following Board**  
7 **approval, with two options to extend the contracts for up to one year each at the sole**  
8 **and absolute discretion of the City.**

10 WHEREAS, Charter, Section 9.118(b), requires the Board of Supervisors to approve  
11 by Resolution contracts estimated to cost the City \$10,000,000 or more; and

12 WHEREAS, The Office of Contract Administration has conducted a Request-for-  
13 Proposal process to add four proposed Tier 1B contracts to the existing Technology  
14 Marketplace to facilitate the ordering of information-technology related products and  
15 services; and

16 WHEREAS, The contract referenced above is substantially in the form attached and  
17 are on file with the Clerk of the Board of Supervisors in File No. 160416, which are hereby  
18 declared to be a part of this Resolution as if set forth fully herein; now, therefore, be it

19 RESOLVED, That the Board of Supervisors authorizes the Purchaser and Director of  
20 the Office of Contract Administration to execute the contract for the Technology  
21 Marketplace purchases in the amount described above for the term ending three years after  
22 enacted, to commence following Board approval, with two options to extend the contracts  
23 for up to one year each at the sole and absolute discretion of the City; and, be it

1           FURTHER RESOLVED, That within thirty (30) days of the contract being fully  
2 executed by all parties, the Purchaser and Director of the Office of Contract Administration  
3 shall provide the final contract to the Clerk of the Board for inclusion into the official file.
