3 **Resolution determining that the issuance of a Type 20 off-sale beer and wine**
4 **license to Raton 927 LLC, dba Raton 927 located at 927 Post Street (District 6),**
5 **will serve the public convenience or necessity of the City and County of San**
6 **Francisco in accordance with California Business and Professions Code, Section**
7 **23958.4, and recommending that the California Department of Alcoholic Beverage**
8 **Control impose conditions on the issuance of the license.**

10 WHEREAS, Raton 927 LLC, is seeking the issuance of a Type 20 off-sale beer
11 and wine license for Raton 927 located at 927 Post Street (District 6); and

12 WHEREAS, The Planning Department has verified that the area is properly
13 zoned and recommends approval; and

14 WHEREAS, The Police Department has filed six (6) protests with the Department
15 of Alcoholic Beverage Control under California Business and Professions Code, Section
16 24013, and recommends that the Department of Alcoholic Beverage Control issue the
17 liquor license with conditions; and

18 WHEREAS, The conditions recommended by the Police Department are the
19 following: 1) sales of alcoholic beverages shall be permitted only between the hours of
20 7:00 a.m. to 12:00 a.m. midnight daily; 2) no noise shall be audible beyond the area
21 under the control of the licensee as defined on the ABC-257, dated 2/22/2016; 3) no
22 malt beverage shall be sold with an alcoholic content greater than 5.7% by volume; 4)
23 the sales of beer or malt beverages in quantities of 16 oz., 20 oz., 32 oz., 40 oz., or
24 similar size containers is prohibited; 5) loitering (is defined as "to stand idly about; linger
25 aimlessly without lawful business") is prohibited on any sidewalks or property adjacent

1 to the licensed premises under the control of the licensee as depicted on the ABC-257,
2 dated 2/22/2016; 6) no beer or malt beverage shall be sold in quantities of less than
3 manufacturer pre-packaged six packs per sale with the exception of wine-coolers, beer
4 coolers which must be sold in manufacturer pre-packaged multi-unit quantities of four
5 (4) or more; and 7) wine shall not be sold in bottles or containers small than 750 ml;
6 now, therefore, be it

7 RESOLVED, That in accordance with California Business and Professions Code,
8 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
9 hereby determines that the issuance of a Type 20 off-sale beer and wine license to 927
10 LLC, dba Raton 927 located at 927 Post Street (District 6), will serve the public
11 convenience or necessity of the City and County of San Francisco; and, be it

12 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
13 San Francisco hereby endorses and adopts the recommendations of the Police
14 Department listed above and recommends that the Department of Alcoholic Beverage
15 Control issue the license with those conditions.
