Notice of these meetings are posted 30-days prior to the meeting with the Clerk’s office of the San Francisco Board of Supervisors and at the San Francisco Public Library.

**Notice of attendance:** Community Initiatives respectfully requests that attendees notify us in advance if they plan to attend a public meeting. Please send an email to [info@communityinitiatives.org](mailto:info@communityinitiatives.org) or call (415) 230-7700 and provide your full name for the building’s security access.

**Admission to the meeting:** The Open to the Public portions of the meetings typically run from 9:00 am to 11:00 am.

**Seating:** Please enter the room at an appropriate time to not disturb the conversation and take a seat in the designated public seating area (not at the conference table).

**Comments:** Public attendees may be asked to introduce themselves but are present as observers, not participants. They will be given an opportunity to comment at the end of the business meeting, immediately preceding the Board's regularly scheduled executive sessions. The Board's executive sessions are closed sessions and are not open to the public.

**Public comments are limited to five (5) minutes per attendee, with a combined limit of thirty (30) minutes for all comments.**
