NEXT MEETING LOCATION: Under the guidance and directives from the San Francisco Department of Public Health regarding COVID-19, and public gatherings, the May 26 Board Meeting will be held remotely, with all persons – Board members and the public – participating either by telephone or via internet video conferencing.

Accessing the meeting on May 26 by telephone

- Telephone participants are invited to call in at +1(669)900-6833 (San Jose) or +1(213)338-8477. Upon calling in, you'll receive a message saying, "Welcome to Zoom. Please enter your meeting ID, following by pound." Respond by typing in the following digits and # sign: 375 830 8999#
- Next, you will hear "Please enter your participant ID, followed by pound. Otherwise, just press pound." Respond by simply pressing #.
- Upon entering the meeting, you'll be asked by a host if you are a Board member or a member of the public and be placed in a waiting room until the meeting begins. If you wish to speak during the public comments section, you can register your intent at this time.
