Motion concurring in actions taken by the Mayor in the Forty-Fourth Supplement to the Proclamation of Emergency to meet the ongoing local emergency related to the novel coronavirus COVID-19 pandemic by authorizing the Controller to develop and issue a policy to allow the City to continue to provide funding under existing agreements to non-profit organizations that are unable to provide services under contracts or grant agreements with the City due to disruptions related to COVID-19 during the local emergency, and authorizing a program to provide additional paid sick leave to City employees and "as needed" employees to be used for COVID-19 infection, COVID-19 exposure, or direct impacts of COVID-19 on employees and their families.

WHEREAS, On February 25, 2020, Mayor London N. Breed declared a local emergency to exist in connection with the spread of the novel coronavirus COVID-19; and

WHEREAS, The Mayor transmitted a copy of that Proclamation Declaring the Existence of a Local Emergency to the Board of Supervisors (the "Proclamation"), and on March 3, 2020, the Board of Supervisors concurred in the Proclamation and in the actions taken by the Mayor to meet the emergency; the Proclamation and the Board's concurring motion are on file with the Clerk of the Board of Supervisors in File No. 200228; and

WHEREAS, On March 6, 2020, the Health Officer declared a local health emergency under Section 101080 of the California Health and Safety Code, and the Board of Supervisors concurred in that declaration on March 10, 2020; and

WHEREAS, In the past several weeks, the City has seen exponential growth in the number of confirmed COVID-19 cases due to the arrival of the highly transmissible Omicron

23 24 25 variant, causing a sharp rise in City employees' use of sick time, as many City employees have been required to isolate and quarantine due to COVID-19 infection and exposure; and

WHEREAS, The City's non-profit service partners similarly have suffered disruptions due to employees' need to stay home from work due to infection or exposure; and

WHEREAS, On January 20, 2022, the Mayor took additional steps to meet the emergency by issuing the Forty-Fourth Supplement to the Proclamation, ordering two actions to meet the emergency; the Forty-Fourth Supplement is on file with the Clerk of the Board of Supervisors in Board File No. 220100; and

WHEREAS, Government Code, Sections 8550 et seq., and Charter, Section 3.100, provide for the concurrence by members of the Board of Supervisors in such emergency declaration and in action taken by the Mayor to meet the emergency; and now, therefore, be it

MOVED, That the Board of Supervisors concurs with the following actions taken by the Mayor to meet the local emergency included in the Mayor's Forty-Fourth Supplement to the Proclamation, dated January 20, 2022, as such actions are described in full in the Forty-Fourth Supplement and summarized as follows:

Action 1: Authorizing the Controller to develop and issue a policy to allow the City to continue to provide funding under existing agreements to non-profit organizations that are unable to provide services under contracts or grant agreements with the City due to disruptions related to COVID-19 during the local emergency, and suspending provisions of service agreements and of local law to the extent they would impede such continued payments authorized under the policy promulgated by the Controller.

Action 2: Authorizing a program to provide additional paid sick leave to City employees and "as needed" employees to be used for COVID-19 infection, COVID-19 exposure, or direct impacts of COVID-19 on employees and their families such as school closures or remote or hybrid learning programs, and waiving any provisions of the Charter, the

Municipal Code, and City rules or regulations that would limit or prevent this additional sick leave benefit.
