13 Housing Authority, Section 2.2), for the terms specified:

14 Sharon Wai Sum Lai, seat 6, inaugural appointment, must be a resident of San
15 Francisco recommended by the Board of Supervisors (cannot be a previous Housing
16 Authority Commissioner), for a four-year term ending December 16, 2028 (Ends three-years
17 from the date of approval);

18 Cynthia Alvarez, seat 7, inaugural appointment, must be a resident of San Francisco
19 recommended by the Board of Supervisors, for a four-year term ending December 16, 2029.
20 (Ends four-years from the date of approval).
