Section 1. Environmental Findings. The Planning Department has determined that the actions contemplated in this ordinance comply with the California Environmental Quality Act (California Public Resources Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of Supervisors in File No. 250603 and is incorporated herein by reference. The Board affirms this determination.

Section 2. Article 12 of the Park Code is hereby amended by revising Section 12.41, to read as follows:

SEC. 12.41. TENNIS/PICKLEBALL FEES.

- (a) The following hourly fees shall be charged to reserve tennis/pickleball courts at locations other than the Golden Gate Park Tennis Center:
 - (1) Reservations made by Individuals not more than one week in advance: \$5
