**Ordinance amending the Park Code to authorize the Recreation and Park Department to charge fees for reserving tennis/pickleball courts at locations other than the Golden Gate Park Tennis Center; and affirming the Planning Department's determination under the California Environmental Quality Act.**

Be it ordained by the People of the City and County of San Francisco:

Section 1. Environmental Findings. The Planning Department has determined that the actions contemplated in this ordinance comply with the California Environmental Quality Act (California Public Resources Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of Supervisors in File No. 250603 and is incorporated herein by reference. The Board affirms this determination.

Section 2. Article 12 of the Park Code is hereby amended by revising Section 12.41, to read as follows:

**SEC. 12.41. TENNIS/PICKLEBALL FEES.**

*(a) The following hourly fees shall be charged to reserve tennis/pickleball courts at locations other than the Golden Gate Park Tennis Center:*

*(1) Reservations made by Individuals not more than one week in advance: \$5*

1                   (2) Reservations made more than one week in advance:

2                   (A) Not-for-Profit Organization or Individual: \$20 per hour

3                   (B) For-Profit Organization: \$40 per hour

4           **(b)** The following hourly fees shall be charged for court reservations at the Golden  
5 Gate Park Tennis Center ~~upon completion of the renovations described in Board of Supervisors File~~  
6 ~~No. 180464~~, subject to annual adjustment beginning with ~~f~~Fiscal ~~y~~Year 2018-2019 in  
7 accordance with Section 12.20:

10           Section 3. Effective Date. This ordinance shall become effective 30 days after  
11 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
12 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
13 of Supervisors overrides the Mayor's veto of the ordinance.

15           Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors  
16 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,  
17 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal  
18 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment  
19 additions, and Board amendment deletions in accordance with the "Note" that appears under  
20 the official title of the ordinance.




