8 **entitled Tommy O. Johnson, by and through his Attorney-in-Fact Rev. Doris White and**
9 **John Doe, by and through his conservator Thomas O'Connor, on behalf of themselves**
10 **and all others similarly situated v. City and County of San Francisco, et al.; the lawsuit**
11 **involves claims of elder/dependent adult abuse, invasion of privacy, negligence, and**
12 **violations of patients' rights brought by over 700 former and current residents of**
13 **Laguna Honda Hospital.**

15 Be it ordained by the People of the City and County of San Francisco:

16 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
17 authorizes the City Attorney to settle the action entitled Tommy O. Johnson, by and through
18 his Attorney-in-Fact Rev. Doris White and John Doe, by and through his conservator Thomas
19 O'Connor, on behalf of themselves and all others similarly situated v. City and County of San
20 Francisco, et al., San Francisco Superior Court, Case No. CPF-20-517064, by the payment of
21 \$5,845,000. The lawsuit involves claims of elder/dependent adult abuse, invasion of privacy,
22 negligence, and violations of patients' rights brought by over 700 former and current residents
23 of Laguna Honda Hospital.

24 Section 2. The above-named action was filed in San Francisco Superior Court on
25 March 24, 2020, and the following parties were named in the lawsuit: Plaintiffs: Tommy O.

Johnson, by and through his Attorney-in-Fact Rev. Doris White and John Doe, by and through
his conservator Thomas O'Connor, on behalf of themselves and all others similarly situated;
Defendant: City and County of San Francisco.






