6 **21, 2022; the grievance involves an employment dispute under the City’s Memorandum**

10 County of San Francisco; and

11 WHEREAS, the grievance involves the City’s MOU-mandated contributions to the
12 Union’s Apprenticeship Training Fund; and the City will make contributions to the Training
13 Fund for the time period January 1, 2020, through January 31, 2023; and

14 WHEREAS, the Department of Human Resources has recommended settlement of the
15 grievance by payment of \$1,022,500; now, therefore, be it

16 RESOLVED, that pursuant to Administrative Code, Section 10.22, the Board of
17 Supervisors hereby authorizes the City Attorney to settle and compromise the grievance by
18 payment of \$1,022,500.
