3 **Resolution retroactively authorizing the Office of Economic and Workforce**
4 **Development to accept and expend a grant in the amount of \$150,000 from the**
5 **University of California, San Francisco (UCSF) for the CityBuild program to assist**
6 **UCSF’s Construction Community Outreach Program in achieving their voluntary local**
7 **hire goal of 30% on UCSF projects during the grant period of July 1, 2022, through**
8 **June 30, 2023.**

10 WHEREAS, The Administrative Code requires City departments to obtain Board of
11 Supervisors’ approval to accept or expend any grant funds (Section 10.170 et seq.); and

12 WHEREAS, The University of California, San Francisco (UCSF) awarded the Office of
13 Economic and Workforce Development (OEWD) in the amount of \$150,000, to provide
14 employment networking services to UCSF’s Community Construction Outreach Program
15 (CCOP); and

16 WHEREAS, Matching funds not required by Grantor; and

17 WHEREAS, The grant does not require an Annual Salary Ordinance amendment; and

18 WHEREAS, The grant budget includes provision for indirect costs of \$13,636.36; now,
19 therefore, be it

20 RESOLVED, That the University of California, San Francisco may fund the Office of
21 Economic and Workforce Development; and, be it

22 FURTHER RESOLVED, That the Office of Economic and Workforce Development is
23 responsible for the oversight of the UCSF funding for the City and County of San Francisco;
24 and, be it

1 FURTHER RESOLVED, That the Board of Supervisors hereby authorizes the Office of
2 Economic and Workforce Development to accept and expend, on behalf of the City and
3 County of San Francisco, a grant from the University of California, San Francisco for
4 Construction Community Outreach Program in the amount of \$150,000; and, be it

5 FURTHER RESOLVED, That the Director of the Office of Economic and Workforce
6 Development is authorized to enter into the Agreement on behalf of the City
