WHEREAS, On May 30, 2018, the City and County of San Francisco ("City") enacted Ordinance No. 126-18, which added Administrative Code, Chapter 107 to create a process for the establishment of cultural districts in the City to acknowledge and preserve neighborhoods with unique cultural heritage; and

WHEREAS, On August 4, 2021, the City enacted Ordinance No. 121-21, which established the Sunset Chinese Cultural District under Administrative Code, Chapter 107; and

WHEREAS, On March 1, 2022, the Mayor's Office of Housing and Community Development ("MOHCD") published a Request for Proposals ("RFP") as required in Administrative Code, Section 107.4(b)(3) to enter into a grant agreement with a community-based organization to hire a district manager or executive director for the Sunset Chinese Cultural District, and Wah Mei School was awarded as the grantee; and

WHEREAS, Administrative Code, Section 107.4(b)(7) requires MOHCD to prepare a Cultural, History, Housing, and Economic Sustainability Strategy Report ("CHHESS") report for each Cultural District, and to submit the CHHESS report to the Board of Supervisors for adoption by Resolution; and

WHEREAS, In accordance with the grant agreement between MOHCD and Wah Mei School, the Sunset Chinese Cultural District conducted extensive community outreach and engagement to inform strategies for the CHHESS report; and

WHEREAS, MOHCD, in partnership with the Sunset Chinese Cultural District, the Office of Economic and Workforce Development, the Planning Department, and the Arts Commission, completed the Sunset Chinese Cultural District's CHHESS Report, a copy of which is on file with the Clerk of the Board of Supervisors in File No. 250357, and is incorporated herein by reference; now, therefore, be it

RESOLVED, The Board of Supervisors hereby adopts the Sunset Chinese Cultural District's CHHESS submitted by MOHCD.
