WHEREAS, The Lease has a term of 14 years with one two-year option to extend at the Commission's sole discretion, and an initial minimum annual guarantee of \$190,000; now, therefore, be it

RESOLVED, That this Board of Supervisors hereby approves the Direct Current Fast Charging Hub Lease, Lease No. 25-0061, a copy of which is on file with the Clerk of the Board of Supervisors in File No. 250483; and, be it

FURTHER RESOLVED, That within thirty (30) days of the Lease being fully-executed by all parties, the Airport Commission shall provide the final lease to the Clerk of the Board for inclusion into the official file.
