

[Adjusting the Access Line Tax with the Consumer Price Index of 2025]

Resolution concurring with the Controller's establishment of the Consumer Price Index for 2025 and adjusting the Access Line Tax by the same rate.

WHEREAS, The Electorate of the City and County of San Francisco passed Proposition O in November 2008, establishing an Access Line Tax to be imposed upon every person who subscribes to telephone communication services within the City and County of San Francisco (Business and Tax Regulations Code Section 782); and

WHEREAS, Sections 782 (b) and 784 state, in part, that the cap and rates established by this subsection shall be adjusted annually in accordance with the increase in the Consumer Price Index; All Urban Consumers for the San Francisco/ Oakland/San Jose Area for all items as reported by the United States Bureau of Labor Statistics, or any successor to that index, as of December 31st of each year; and

WHEREAS, Sections 782 and 784 also require that this increase be approved, annually, by the Board of Supervisors and the Mayor; and

WHEREAS, The Consumer Price Index for All Urban Consumers for the San Francisco/Oakland/Hayward Area for All Items as reported by the United States Bureau of Labor Statistics increased from 339.9 in December 2023 to 348.0 in December 2024, an increase of 2.38%; and

WHEREAS, The monthly rates are currently set at \$4.26 per Access Line, \$32.06 per Trunk Line, and \$577.26 per High Capacity Line and the Annual Cap is \$85,544.12; and

WHEREAS, The new monthly rates will be \$4.36 per Access Line, \$32.82 per Trunk Line, and \$590.99 per High Capacity Line and the new Annual Cap will be \$87,579.07; and

1 WHEREAS, The Controller's certification of the Consumer Price Index rate is on file
2 with the Clerk of the Board of Supervisors in File No. 250612, which is hereby declared to be
3 part of this resolution as if set forth fully herein; now, therefore, be it

4 RESOLVED, That the Board of Supervisors hereby approves the adjustment of the
5 Access Line Tax by the 2025 Consumer Price Index.




