Resolution approving an Agreement between the City, acting by and through the Human Services Agency, and Seneca Family of Agencies for the provision of Family and Children's Services (FCS) Wraparound Services, for a term of four years from July 1, 2025, through June 30, 2029, and for a total not to exceed amount of \$15,974,640; and to authorize the Executive Director of the Human Services Agency to make necessary, non-material changes to the Agreement before its execution.

WHEREAS, The City and County of San Francisco, by and through its Human Services Agency, wishes to provide funding for services provided to the community for mental health and social services for high needs children in out-of-home placements or at risk of out of home placements through the Family and Children's Services (FCS) or Juvenile Probation systems; and

WHEREAS, On January 16, 2025, the Human Services Agency issued a Request for Proposals #1159 for FCS Wraparound Services for Child Welfare Families; and

WHEREAS, Seneca Family of Agencies submitted a proposal and was the highest ranked proposer; and

WHEREAS, The Human Services Agency awarded the Agreement to Seneca Family of Agencies; and

WHEREAS, The Agreement is consistent with the Civil Service Commission's approval obtained on April 21, 2025, under Personal Service Contract No. DHRPSC0005086; and

WHEREAS, On April 24, 2025, the Human Services Commission approved the proposed Agreement with Seneca Family of Agencies (the "Agreement") in a total amount not

to exceed \$15,974,640 for the period from July 1, 2025, through June 30, 2029; and

WHEREAS, The City and County of San Francisco, by and through its Human Services Agency, now wishes to enter into the Agreement with Seneca Family of Agencies; and

WHEREAS, Charter, Section 9.118(b) requires Board of Supervisors' approval by Resolution of any contract which, when entered into, extends over 10 years, and of any contract which, when entered into, costs the City \$10,000,000 or more; and

WHEREAS, The proposed Agreement contained in File No. 250511, is substantially in final form, with all material terms and conditions included, and only remains to be executed by the parties upon approval of this Resolution; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby approves the Agreement in substantially the form contained in File No. 250511; and, be it

FURTHER RESOLVED, That the Board of Supervisors authorizes the Human Services Agency to make any modifications to the Agreement, prior to its final execution by all parties, that the Human Services Agency determines, in consultation with the City Attorney, are consistent with this Resolution, in the best interest of the City, do not materially increase the obligations or liabilities of the City, are necessary or advisable to effectuate the purposes of the Agreement, and are in compliance with all applicable laws, including City's Charter; and, be it

FURTHER RESOLVED, That within 30 days of the Agreement being fully executed by all parties, the Human Services Agency shall submit to the Clerk of the Board of Supervisors a completely executed copy for inclusion in File No. 250511; this requirement and obligation resides with the Department, and is for purposes of having a complete file only, and in no manner affects the validity of the approved Agreement.
