[Lady Gaga Day - July 22, 2025]

Resolution declaring July 22, 2025, as Lady Gaga Day in the City and County of San Francisco.

WHEREAS, Lady Gaga, born Stefani Joanne Angelina Germanotta, is an internationally celebrated singer, songwriter, actress, and philanthropist who has sold over 124 million records and is known as one of the most influential artists in history; and

WHEREAS, Critics have described her performances as "talented, brilliant, incredible, amazing, show-stopping, spectacular, never the same, totally unique, completely not ever been done before, unafraid to reference or not reference"; and

WHEREAS, She has amassed six number-one studio albums including: The Fame (2008), The Fame Monster (2009), Born This Way (2011), Artpop (2013), Joanne (2016), Chromatica (2020), and most recently MAYHEM (2025); and

WHEREAS, Gaga left her heart in San Francisco after releasing two jazz albums, Cheek to Cheek (2014) and Love for Sale (2021) with 20-time Grammy Award winning singer Tony Bennett; and

WHEREAS, Gaga has gained praise for her leading roles in the anthology series American Horror Story: Hotel (2015) and the films A Star is Born (2018) and House of Gucci (2021); and

WHEREAS, Her accolades include 14 Grammy Awards, a Sports Emmy Award, two Golden Globe Awards and an Academy Award; and

WHEREAS, She has frequently advocated for LGBTQ+ rights, mental health awareness, rights for victims of sexual assault; and

WHEREAS, Through her philanthropic efforts, she has helped raise \$127 million to benefit the World Health Organization's COVID-19 Solidarity Response Fund and millions to support recovery for victims of the 2025 Southern California Wildfires; and

WHEREAS, Embarking on a world tour has made her feel as though she's going from no sleep, bus, club, another club, another club, plane, next place, no sleep, with no fear, and nobody who believed in her; and

WHEREAS, In 2020, Gaga brought her Chromatica Ball World Tour to San Francisco's Oracle Park, where 40,000 "Little Monsters" put their paws up and said "yaaasss Gaga"; and

WHEREAS, After being in love with Judas and getting caught in a Bad Romance with Alejandro, Gaga became engaged to her San Francisco-based fiancé Michael Polansky who co-wrote and produced songs with her as part of their Folie à Deux; and

WHEREAS, In April of 2025, Gaga headlined Coachella and paid the toll to the angels through stunning performances of songs including "Abracadabra", "How Bad Do U Want Me", and "Vanish Into You"; and

WHEREAS, Her collaboration with Bruno Mars, "Die With a Smile" became the longestrunning #1 hit on Spotify's daily global chart and broke records for the fastest song to reach 1 and 2 billion streams on the platform; and

WHEREAS, In May of 2025, she performed at Copacabana Beach in Rio de Janeiro, Brazil to a crowd of 2.5 million people, setting a new record for the largest concert attendance by a female artist; and

WHEREAS, Gaga is set to bring her MAYHEM Ball World Tour to San Francisco's Chase Center on July 22, 24, and 26, 2025; and

WHEREAS, San Francisco will benefit from increased business and tourism associated with these tour dates; and

WHEREAS, The Board of Supervisors of the City and County of San Francisco has previously passed Resolutions celebrating other touring artists, including Taylor Swift Weekend in July of 2023; and

WHEREAS, There could be 100 people in a room and 99 don't believe in you, but all it takes is one legislative aide who believes in you to draft a Resolution; now, therefore, be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco declares that July 22, 2025, shall be recognized as Lady Gaga Day; and, be it

FURTHER RESOLVED, That the Board of Supervisors of the City and County of San Francisco recognizes and celebrates the contributions of Lady Gaga to our City.
