6 WHEREAS, Administrative Code, Section 19B.6 requires City Departments that obtain  
7 approval for the acquisition of Surveillance Technology under Section 19B.2 to submit to the  
8 Board of Supervisors and the Committee on Information Technology (COIT) an Annual  
9 Surveillance Report for all Surveillance Technology used by the Department; and

10 WHEREAS, The Annual Surveillance Report is due within 12 months of Board approval  
11 of the applicable Surveillance Technology Policy, and on or before November 1 every two  
12 years thereafter; and

13 WHEREAS, The San Francisco Municipal Transportation Agency (SFMTA) has  
14 obtained Board approval for the acquisition of Surveillance Technologies under Section 19B.2  
15 and is therefore required to submit an Annual Surveillance Report for the 2025 reporting  
16 period; and

17 WHEREAS, The SFMTA has submitted to COIT—and COIT has received and  
18 reviewed—the Annual Surveillance Report for the 2025 reporting period, which includes the  
19 following Surveillance Technologies: Automatic Speed Enforcement (ASE) and Driver-Safety  
20 Video Analytics ; and

21 WHEREAS, The Annual Surveillance Report for the 2025 reporting period is available  
22 for review in Board File No. 250920; now, therefore, be it

23 RESOLVED, That the Board of Supervisors of the City and County of San Francisco

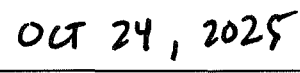
