WHEREAS, The Board of Supervisors of the City and County of San Francisco hereby recognizes United Against Hate Week, to be held November 12, through November 18, 2023; and

WHEREAS, The City and County of San Francisco encourages residents, businesses, and community organizations to actively participate in United Against Hate Week by organizing and attending events that promote unity and understanding; and

WHEREAS, The City and County of San Francisco reaffirms its dedication to the principles of diversity, inclusion, and respect for all, and condemns all forms of hate and discrimination; and
